### **Update**

Ahu Whenua Trophy goes to Erepeti.

On Saturday 20<sup>th</sup> June, Erepeti Marae and the people of the Ruakituri valley hosted Bart and Nuku Bradfield and Hannah Wallace in a congratulatory dinner and get together. Attended by Mayor Craig Little and his wife, there was a definite air of pride not just for Erepeti but for the whole Wairoa district.

### Stark Raving Film Crew

The last couple of weeks have been particularly busy as I have taken on the role of Exec Producer for the Stark crew and have, and still are, getting them around to as many attractions, sites, events and local identities as we can. The goal for this exercise is to accumulate as much film and photo footage as possible to use towards promotion of Wairoa district and its people. Some of our projects have been:

- Ruakituri River with Dave Withers; spoke mainly on the river, trout fishing, early farmers and SAR; tied in a few stories with Lake Waikaremoana which we hope to tidy up when we finally get up there; links with Te Kooti skirmishes and a relationship with Earl Carr in England who donated a walking stick to Erepeti Marae; memorial plaques to some of the fighting dead who tried to fight Te Kooti at Papuni Station
- Te Reinga falls whilst this was in flood it was a truly spectacular sight will go back when the river cleans up a bit so can take some footage of the Ruakituri the Maori stories surrounding the falls will be recorded at a later time and probably overlaid into the footage.
- Matariki Community concert Austen was able to get a lot of footage of the entertainment throughout the night including Susan Rose, Matiu Dallas, Wairoa College Band and Cover5.
- Wairoa Bull sale apparently the crew were amazed at seeing these huge animals close up, but even more amazed at the prices some of them went for.
- Shearing at Makapua station Margaret again amazed the crew at her prowess of the shears and so they got a lot more footage of the day's activities no deer hunting so hopefully we can get deer in the camera when we go to Mark and Katie Bowens.
- Whakapunake Mountain the farm manager failed to tell us there was snow on the mountain! Luckily I borrowed a 4wd from Helens department for myself and some elders I picked up to accompany us. The Stark crew got stuck near the top, and so had to break ice and dig some of the road up a bit in order for their car to get traction they won't forget this trip in a hurry! Views at the top were amazing, as you would expect. However there was cloud over Taupo and some over south Hawkes Bay so we couldn't give them the best visuals we know the mountain could have done. At least Whakapunake didn't blow us off the top as I know it has done for other visitors. Some history was provided by one of the elders but again the narrative will be recorded separately and then edited into the film.

- Morere Hot Springs again an amazing experience for the crew some great footage was got as well as a good interview by the current operators Paul and Wendy Hohipa – I do think we should be doing a bit more to promote this place despite being land banked by OTS.
- Te Kapu Honey at Frasertown Keith and Joe Pegram gave us a tour of the factory and grounds; despite being closed down for the winter period I think there was enough footage obtained to create some good vision; we also got a good interview with the two of them talking about the business and a little bit of Keiths family history.
- Will be in contact with Mark and Katie Bowen to organise the Mahia Venison and Crayfish
  experience; as well as that we are planning Lake Waikaremoana. The lake might have to go
  over two days being such a large area and so much history to record. We have yet to get to a
  marae, amongst other things, and I will also get them to Mohaka and maybe out to Putere.

As you probably aware by now voting for the poll will run from 24<sup>th</sup> August to 15<sup>th</sup> September 2015. We need to encourage our people to check and ensure they are registered on the electoral roll as the close off date for registrations is 20<sup>th</sup> July. Whilst we are bound by legislation to refrain from expressing support or otherwise to this poll while engaged in Council business; as a private citizen we can speak to the issue face to face.

### **RE: LOCAL GOVERNMENT COMMISSION PUBLIC OPINION SURVEY**

Thank you for your letter to Basil Morrison, Chair of the Local Government Commission, and me regarding the Commission's recent survey on its proposal for reorganisation of local government in Hawke's Bay. Mr Morrison has asked me to reply to you on his behalf.

As your letter notes, Colmar Brunton recently undertook a large public opinion survey on behalf of the Commission. The purpose of the survey was to enable the Commission to understand the various views of the people of Hawke's Bay on the Commission's proposal. More than 2,000 people aged over 18 were surveyed, including 400 in Wairoa.

Your letter raises the matter of whether the survey results fairly represent and reflect the views of Wairoa tangata whenua, and cites statistics showing that many Māori in Wairoa do not have landlines.

I understand the issue you have raised, and that is why before undertaking the survey we worked with Colmar Brunton to ensure the methodology they used for the survey was robust enough to give the Commission confidence the results would fairly reflect the views of the communities in Hawke's Bay, including those of Māori who live in Wairoa.

Colmar Brunton interviewed 400 Wairoa residents aged 18 years and over, of whom 44% identified themselves as Māori. While, as you note, Māori make up 59% of the total population of Wairoa, Māori who are 18 years of age and older make up 54% of the 18+ population in Wairoa.

Weighting to allow for over- or under-representation of populations (e.g. for age, ethnicity, income) in surveys is a common tool to ensure that organisations can have confidence that the results of surveys represents the populations being surveyed. Colmar Brunton gave more weight to the responses from those who identified as Māori from Wairoa so the views of Māori represent 54% of all those aged 18+ who were surveyed in Wairoa.

On a related point, I do not agree the questions posed in the survey reflect bias as your letter suggests. Colmar Brunton has been very clear with the Commission that they consider both the methodology and questions in the survey to have a very high level of integrity and the Commission can have confidence in the results of the survey.

Your letter also states there was no or little consultation with Māori in Wairoa prior to the survey being undertaken. While I acknowledge the Commission should always look to ways in which it can improve its engagement with communities, I note the Commission has:

- publicly called for submissions on the draft reorganisation proposal from all interested parties in Wairoa and across Hawke's Bay;
- held hearings in each local district and made a particular effort to contact Māori who had made submissions to attend those hearings and address the Commission. This included the Māori Standing Committee of Wairoa District Council;
- initially planned for the Wairoa hearing to be held at a local marae, acknowledging that Māori represent a majority of people in Wairoa, however the Wairoa District Council arranged an alternative venue in the end.

The Commission looked to engage closely with Māori throughout the process and kanohi ki te kanohi where possible. This was largely at a regional level involving the Hawke's Bay regional planning committee on which Te Tira Whakaemi o Te Wairoa is represented. The reasons for that were in part related to parallel Treaty settlement processes that were underway. In addition to meeting with Māori members of the committee on three different occasions, the Commission met separately with several members of the committee including Ngāti Ruapani ki Waikaremoana and Ngai Tūhoe. The Commission also met with Ngāti Kahungunu lwi Authority.

I trust this letter explains the Commission's approach and helps provide an assurance the survey results reflect the views of Māori in Wairoa on the issue of the proposed reorganisation of local government across Hawke's Bay.
