INFORMATION SHEET - NEW MANAGER'S CERTIFICATE

To complete the application you will need to answer all questions, supply all requested documentation and attach the prescribed fee. Please ensure you attach this information sheet when lodging your application.

Manager's Certificate

A Manager's Certificate authorises the holder to manage any licensed premises. You must be 20 years or older to hold a Manager's Certificate.

New Manager's Certificate Applications

After 18 December 2013, every application for a Manager's Certificate must meet the following criteria:

- The applicant holds a LCQ certificate issued after 18 December 2013, or
- The applicant holds a LCQ certificate issued prior to 18 December 2013, and has successfully completed the "LCQ Bridging Test".

To complete the application you will need to supply the following:

- The non-refundable prescribed fee of \$316.25
- Original application form
- A copy of photo identification
- A copy of proof of eligibility to work in New Zealand (if applicable)
- A copy of your Licence Controller Qualification certificate
- A copy of your Licence Controller Qualification Bridging certificate
- A letter from the employer of the licensed premises where you are working or a letter from the Club you are working at, showing your involvement.
