Please note this application form is for a Renewal of a Manager's Certificate. If you require a **new** Manager's Certificate, please refer to the **'New Manager's Certificate'** application form on our website.

Existing General & Club Manager's Certificates

All existing General Manager's Certificates and Club Manager's Certificates issued under the Sale of Liquor Act 1989, will remain valid until the date of expiry of each individual certificate.

All applications for renewal must be made 20 working days prior to the expiry date of the certificate being renewed.

Renewing existing general & club manager's certificates

After 18 December 2013, an existing General Manager's Certificate or Club Manager's Certificate can only be renewed under the following circumstances:

	If the applicant holds an LCQ certificate issued after 18 December 2013, an application for renewal can be made and a renewed certificate issued under the new Act for a full three year period, or
	If the applicant holds an LCQ certificate issued prior to 18 December 2013, and has successfully completed the "LCQ Bridging Test", an application for renewal can be made and a renewed certificate issued under the new Act for a full three year period, or
	If the applicant does not meet either of the two criteria listed above, an application can be made for a "limited renewal certificate" allowing the holder a one-year grace period in which to obtain the required qualifications.
