WASTEWATER PROGRESS

We are making progress around Wairoa's wastewater discharge consent application which was lodged with the Hawke's Bay Regional Council at the end of last vear.

The work around this application was approved in the 2017/18 Long Term Plan and is one of the most significant infrastructure projects Wairoa has seen in 30 years.

The multi-million-dollar expenditure will include renewals of the

wastewater reticulation system, renewal works on the oxidation ponds and consent process development and works.

SINCE THE COUNCIL'S APPLICATION WAS LODGED, OUR STAFF HAVE BEEN WORKING WITH THE HAWKE'S BAY REGIONAL COUNCIL WITH SITE VISITS AND PROVIDING INFORMATION REQUESTED BY THEM.

This is a significant undertaking and may take the whole year before consent is granted.

I know the Hawke's Bay Regional Council is making a real commitment to helping us.

They accept we are on a journey to rectify our issues and acknowledge this is not an overnight fix and are working with us. We understand they are the regulatory body and we are working with them to provide the information as they request it.

Our staff have been designing a solution so when the application is approved, we will be shovel ready to begin physical work which will include removing the overflow pipe.

We are also working with the regional council around options to mitigate overflow risks in the short-term.

While we are in the consent process, our hands are tied, so it is a matter of placing ourselves in the best position to get started once the approval does come through.

I believe our town is very fortunate to have an engineering team, led by Stephen Heath, which is passionate about getting our wastewater system 100 percent correct and compliant.

WE ADE ALSO FODTUNATE TO HAVE HAD INDUT FROM THE COUNCIL INITIATED WAIROA WASTEWATER STAKEHOLDER GROUP.

This group was formed at the beginning of the wastewater consultation period and reflects a cross-section of the community and has been invaluable in the process which is being worked through.

The wastewater group had its work recognised as a finalist in both the 2018 Local Government New Zealand (LGNZ) Community Engagement EXCELLENCE Awards and the Society of Local Government Managers (SOLGM) Community Engagement Awards. The new consent will include the ongoing involvement of the stakeholder group to help Council review progress towards its

This process is a community and iwi partnership, and our intention is based around long-term, sustainable and affordable solutions for Wairoa.

This is a new era with new regulations and future proofing our wastewater system is not negotiable.

This is not just a Council issue, it is an issue that affects everyone, and as your elected representatives we are working to ensure we can supply the best, and most affordable solution.

This is an issue facing New Zealanders all over the country and I commend this council and its staff for addressing it and getting on

It would be great to see Central Government step in and assist us with funding, so it is not being totally met by the ratepayer.
