THREE WATERS REFORM **SURVEY**

am continually told by our community and iwi that they have not heard enough information around the government's proposal to reform the drinking, waste and storm water (three waters) sector.

They are telling me they cannot understand how the proposal has progressed to the stage it has when they have not personally received any information about the changes.

While this is a government reform,

the Wairoa District Council, along with other local authorities, has been asked by the government to consider the evidence and whether the government's proposal to reform the water sector will deliver benefits to its residents.

The government has given all councils until 30 September 2021 to analyse the proposal and feed back to them.

Our Council has designed a survey as a way of gathering people's thoughts. We urge you to complete the survey and add any additional comments you may want to share.

I don't believe the government has put out enough information around this radical change. If this proposal goes through it will have a massive impact on council, community and iwi, and I find it farcical that the government is not talking to individual communities as the decisions will affect these communities for many more years to come.

We really need to hear from our community and jwi as it is important the information our Council feeds back to the government is reflective of our people.

The proposal comprises significant change and also leaves a lot of unanswered questions.

While I agree we need to make changes in the Three Waters sector, I don't believe amalgamating the water services of the 67 local authorities into four new regional statutory corporations, with centralised management and a new governance structure, is the

I do accept that providing Three Waters services into the future could become very expensive with changes in the regulatory environment, infrastructure, growth, and climate change.

My concern is, under this proposal will Wairoa still have a voice, or will we lose our localisation, and will we still own our assets? The government proposes to amalgamate the water services of the Wairoa District Council into a new statutory corporation called 'Entity C' which will see Wairoa included along with the East Coast, the rest of Hawke's Bay, down to Wellington, and the top of the South Island. This area covers close to one million people and 21 councils - Wairoa would make up one percent of the combined local councils in the entity.

The key question is, will the Reform Scenario deliver the claimed benefits, and will Wairoa be better off under the proposed scenario? Hawke's Bay's councils have collectively discussed the impacts of becoming part of Entity C and are investigating options including developing a regional approach.

By gathering the thoughts of our community and iwi we will be able to clearly state what is important to our community in terms of the balance between retaining a local voice in decision-making and ensuring sustainable, affordable, reliable, and safe water services in

HEAVY RAINFALL EVENT

Last week's heavy rainfall event was certainly what most farmers wanted to set their stock feed situation up for the coming months.

In town there were reports of more than 100mm falling within a 48hour period.

This put a lot of pressure on Council's infrastructure and particularly our stormwater and wastewater network.

A main issue for us was the storm water infiltration into our wastewater network. We have made significant improvements around this area over the last couple of years but there is still work

Some of the projects we are currently carrying out through the \$11m Three Waters stimulus package will continue to build our resilience. These include the water toby upgrade with backflow prevention devices and electronic water meters, CCTV filming of the inside of wastewater pipes, wastewater pipe relining, and wastewater treatment plant improvements including dedicated pump station generators.

The heavy rainfall also caused a few localised slips and one road closure due to flooding, but predominantly our roading network held up well considering how much rain fell in a short timeframe.
