It is also important people source their information from reliable and genuine sources. There is a lot of misinformation being spread and I urge everyone to do their research and ensure their information is accurate.

We know we will have a lot of visitors to our beautiful district over the summer and it is important we protect them and of course protect our local communities.

Wairoa is remote, and we have many vulnerable people and limited health resources to support them. Our nearest ICU is two hours away and we have no ventilators, so it is important to keep our whānau safe.

I wish you all a very Meri Kirihimete and all the best for a prosperous 2022 - but above all please stay safe and be kind.

#### THREE WATERS

Last week I went to Wellington as part of a group of Mayors who represent more than a million New Zealanders. We took our Three Waters concerns to Parliament marking the first step of a powerful new local democracy campaign.

Communities 4 Local Democracy - He hapori mo te Manapori is a newly formed and growing group of Councils, that was created in response to serious concerns about the Government's Three Waters reforms, in particular losing control of approximately \$60 billion of community owned assets across the whole country.

Like the Government, we want to ensure all New Zealanders have access to safe drinking water and we are committed to working with the Government to achieve that. Noone disputes the need for investment, but there's a better way to achieve the Government's objectives and we want to work in partnership with them on that.

Our action group will introduce fresh ideas for better water that will ensure our local communities continue to have a say on how the assets that they have bought and paid for are used to achieve our health and environmental goals.

We don't believe the best solution is losing our assets and transferring them into what will be four of the largest companies in New Zealand - and then denying our communities their say in how those companies are run.

Communities 4 Local Democracy is taking a constructive approach to the situation by commissioning expert advice on alternative models that might achieve the objectives of Government and local communities. It will be sharing its findings when they are complete.

This group of Councils is not anti-Government or anti-change. It is about sensibility and finding the best solutions for our legacy of issues.

The government's decision does not reflect the concerns of communities and councils and the Three Waters Reform takes away local voice and local ownership.

Wairoa's elected members have heard feedback from our communities and are united in their opposition to the government's decision to legislate to mandate local councils to hand over their drinking water, wastewater and storm water assets to four new multi-regional entities.

#### THOUGHTS FROM MORE OF OUR ELECTED MEMBERS ON THE GOVERNMENT'S THREE WATERS REFORM:

Hine Flood: The government's decision to go ahead with its proposal to reform three waters comes as a huge blow to our community and we need to continue to act cautiously. There needs to be change, but the promises by this current Labour dominated government leaves much to chance over the next 30 years, including the ownership of our assets.

What assurance will Wairoa have to timely access and service provision? What are the guarantees around local employment relative to current, emergent and appropriately resourced delivery? Asset ownership, local democracy and voice are huge worries for Wairoa, and let's not forget the debt we will inherit by being forced to become part of Entity C.

Our elected members, Chief Executive and staff, will go over and above the call of duty to protect and preserve the services our community expects. There is still much work to be done and a newly appointed committee has been established to now work with Councils and Iwi/Māori for the next phase of this government's 'desired' three waters reform portfolio.

This next stage needs you, our community to engage to help provide proactive solutions to the inevitable change we are facing.

Melissa Kaimoana: I worry Wairoa will in large lose its voice. To date central government has moved without meaningful consultation with our communities and our Councils which own and manage these three water assets. I am concerned the priorities identified by Wairoa will not be prioritised in future planning. I find it very distasteful that Wairoa's assets will be used as leverage for other communities.
