EMISSIONS PRICING PROPOSAL SUBMISSION

Wairoa District Council, like many others, has lodged an individual submission to the Government's He Waka Eke Noa emissions pricing proposal.

Our Council unanimously opposes the proposal in its entirety and is standing up to protect our rural communities. The consequence of this proposal has huge ramifications for our district. This is another example of the government railroading its way through without taking its communities on the journey because of a lack of consultation.

We have also led a regional submission and assisted many more people to individually lodge their own submissions.

It is really disappointing that our Council has had to invest so much time and resources into opposing a proposal that clearly has not considered the current and future needs of rural isolated communities like Wairoa. The government doesn't appear to be looking at the bigger picture, i.e., when productive farmland is completely planted in trees. We should be working in partnership where all of NZ is considered in the government's decision-making.

The emissions pricing proposal is in direct contravention to the wellbeing of Wairoa, and other rural communities, and does not support thriving sustainable communities locally, regionally, and nationally.

We have asked the Government to halt the proposal in its current format, and instead adopt a common-sense science-based approach, rather than a political-based approach, and not neglect meaningful engagement with its communities in order to greenwash on an international platform.

We acknowledge Climate Change is an important issue, but the proposed actions are inappropriate, rushed and predetermined and will disproportionately affect the isolated rural communities of the Wairoa district.

Engagement to date has demonstrated that communities, such as Wairoa, have been overlooked and the technical focus of the proposal neglects to consider the impacts on communities and wellbeing. Historically Wairoa has been marginalised by government policy decisions, often due to "unintended consequences", that have occurred through a lack of understanding of communities outside of the dominant paradigm.

Under this proposal the impacts for Wairoa are astronomical. To make changes of such consequence, without detailing any support policies or intervention, demonstrates a complete disregard for the Government's duty of care to its rural communities.

WATER SERVICES ENTITIES BILL

I was in Wellington, and went to Parliament, along with other Mayors, to listen to the government's reaction to the submissions relating to the Government's Water Services Entities Bill. My experience left me concerned about this government's inability to listen to the views of other

MP Barbara Edmonds said 88,383 written submissions on the Water Services Entities Bill were received and considered. Approximately 82,000 used four different templates or were considered form submissions—by the Taxpayers' Union or the National Party. She said because these 82,000 submissions are identical or substantially identical, the committee aggregated them together and only published one example of each. These 82,000 submissions were described by Hon Minister Edmonds as identical or substantially identical - with some minor personalisation. I am sure the 82,000 people who took the time out to submit would be surprised and disappointed their submissions weren't considered individually.

Just over 200 submissions were actually heard, with the Hon Minister Edmonds saying many of the other approximately 6,000 submitters were not able to be contacted and that is why their submissions were not heard. Again, I am sure members of the public do not sit around waiting for the government to contact them, and it seems incredible, considering the technology we have available to contact and connect with people these days, that contact could not

It is particularly concerning that an issue as controversial as the Three Waters had only a couple of hundred submitters who were able to speak to their submissions, from over 88,000 submissions, and incredible that this seems to be

This is not the democratic process we expect and is why local Councils must continue to be the voice for our grassroots communities in order to stop central government railroading through change that the majority of New Zealanders have clearly identified they do not want.

It is extraordinary that the government did not listen to the people who spent time and money and made an effort to personalise their submissions and put their thoughts forward, and then have their opinions totally ignored.

My biggest concern is this same situation could happen with the He Waka Eke Noa emissions pricing proposal submissions hearing. This consultation process is flawed, and its faults need to be recognised and remedied before the emissions hearings.

Regarding the Water Services Entities Bill, the government has said it will make some amendments, but these changes do not go far enough or address the concerns of the people and are another example of the government trying to trick us into thinking they are listening. Once again, there is not a robust process in place and the government has not stepped away from its original parameters.
